FOI Decision Notice: Sherwood Forest NHS Foundation Trust [FS50840752]

The ICO has found that Sherwood Forest Hospitals NHS Foundation Trust were correct in applying the section 40(2) FOIA exemption (third party personal information) following a request for information relating to numbers of Down syndrome births.
