The Information Commissioner has found that the Department of Health and Social Care (England) were correct in refusing to deny whether it held information an analysis of the impact of Brexit on the NHS citing the section 35(1)(a) FOIA exemption (formation of government policy – no obligation to confirm or deny).

Google has been fined 50 million euros (£44m) by the French data regulator CNIL, for a breach of the EU's data protection rules. Google has since appealed the fine.

News Article: Amazon, Apple and Google face data complaints

Entertainment streaming giants including Amazon, Apple, Google, Netflix and Spotify have been accused of breaking the EU's data regulations.
