# DATA STANDARDS CHANGE NOTICE

# **Introduction**

The Single Cancer Pathway – Adjustments DSCN was first published on 15<sup>th</sup> October 2020. The data set is a patient level data set which along with a separate Single Cancer Pathway – Core data set (DSCN 2020 / 28) were required provide the data necessary to perform key metrics around the Single Cancer Pathway. Health Boards/Trusts were required to record social and medical adjustments and indicate whether the adjustment was exceptional or non-exceptional, however these were not to be included in SCP reporting.

Cancer Wait Times Subgroups were held by Welsh Government in October 2020, with Health Boards and NHS Wales Informatics Service in attendance to provide input in the re-writing of the Cancer Wait Times guidance document. As a result of the changes made to the guidance document (for example CWT pathways are reported based on closed completed pathways, and no adjustments are to be made to the patient pathway), this data set is deemed no longer appropriate nor required. Health Boards will now only be required to report on unadjusted waits.

### Description of Change

This DSCN formally retires the requirement for Health Boards to submit adjusted waits within their cancer wait times returns as a result to the changes made by Welsh Government to the Cancer Wait Times guidance.

### Data Dictionary Version

Where applicable, this DSCN reflects changes introduced by DSCN and/or DDCN since the release of version 4.10 of the NHS Wales Data Dictionary.

The changes introduced by such DSCNs will be published in version 4.11 of the NHS Wales Data Dictionary.

### Actions Required

Actions for all Local Health Boards:

• Health Boards will not be required to report on adjusted waits within their cancer waiting times with immediate effect.

Actions for NWIS Data Standards:

- To retire the Single Cancer Pathway Adjustments data set and to reflect this in the Data Dictionary.
- Ensure WelshPAS are aware of the changes required in the Wales Cancer Tracking Module to remove elements relating to the adjustments data set.

Welsh Government Delivery & Performance Division:

• To cease the formal publication of adjusted waits from February 2021.
