Accident and Emergency Department and admitted to the same

hospital provider.

### **Background:**

On receipt of the English DSCN 13/2004, it was noticed that the definition against the value of '51' and '55 of the 'Source of Admission and Discharge Destination' data item is not consistent with the definition held in the English NHS Data Dictionary. This DSCN is to correct the discrepancy. All other values are consistent with the English definitions.

## **Source of Admission**

### (APC ds99)

The source of admission to a hospital provider spell or a nursing episode when the patient is in a nursing home.

Format: 2 digit numeric

Value	Meaning
19	Usual place of residence unless listed below for example, a private dwelling whether owner occupied by local authority, housing association or other landlord. This includes wardened accommodation but not residential accommodation where healthcare is provided.

# **Discharge Destination**

## (APC ds99)

The classification of where a patient is sent on completion of a hospital provider spell, or a note that the patient died or was a still birth.

Format: 2 digit numeric

51	Other NHS Trust - ward for general patients or young physically disabled or A & E department
52	Other NHS Trust - ward for maternity patients or neonates
