Corporate Information Implications of Trust Mergers

Summary

- 1. This circular informs the service of the actions required to ensure corporate data flows are maintained in light of NHS Trust mergers.
- 2. The standards and procedures should be applied to those information / data submissions in Annex A from 1st April 2008 onwards.
- 3. These standards are being progressed through the Welsh Information Governance and Standards Board (WIGSB).
- 4. A Data Set Change Notice providing relevant data definitional and procedural guidance, highlighting new definitions that will be included within the National Data Dictionary for Wales, will be released shortly once the Statutory Instruments for the new Trusts are in place. In the meantime, the new (interim) Trust codes have been advised to the Trusts affected by the mergers.

Background

5. In July 2007, the Welsh Health Minister Edwina Hart gave the go-ahead for consultation on a series of mergers of NHS Trusts in Wales, with the aim of streamlining management and improving services for patients. The following Trusts have been approved to merge from the 1st April 2008.

Pembrokeshire & Derwen NHS Trust

Carmarthenshire NHS Trust

Pontypridd & Rhondda NHS Trust

North Glamorgan NHS Trust

Swansea NHS Trust

- 6. In order to establish the statutory bodies the Minister has been asked to agree that the following Orders are drafted to effect the mergers:
 - Paragraph 28(1) of Schedule 3 of the National Health Service (Wales) Act 2006 (the 2006 Act) provides that Welsh Ministers may by Order dissolve an

- NHS Trust on the application of the NHS Trust concerned (paragraph 28 (2))(a)).
- Section 18 (1) of the 2006 Act provides that Welsh Minister may by Order establish NHS Trusts to provide goods and services for the purpose of the Health Service.
- Paragraph 28 of Schedule 3 to the National Health Service (Wales) Act 2006 (the 2006 Act) provides that before a Dissolution or Transfer Order is made, prescribed consultation must take place. The current provisions for consultation are contained in the National Health Service Trusts (Consultation on Establishment and Dissolution) Regulations 1996, (which continue to have effect by virtue of paragraph 1(2) of Schedule 2 to the National Health Service (Consequential Provisions) Act 2006 (the Regulations, and Schedule 3 to the 2006 Act.

Corporate Information

- 7. The Information Baseline Work approved by the Corporate Health Information Programme Board in June 2006¹ was utilised as the basis for the data flows which may be affected by the Trust mergers. This was updated to include any further new or amended data / information flows arising after the June 2006 report.
- 8. A process of prioritisation was undertaken by the project team to ensure due consideration was given to each data flow where the Trust was the source. Annex A details those that were deemed "business critical", by the project team based on the dependence on the data for AOF, Efficiency targets and commissioning, and the data submission timescales.
- 9. During 2008-09 there is a requirement to maintain the functionality of current collections to enable the Welsh Assembly Government to track the performance of the former organisations to enable trend comparisons. Following this interim period this guidance will be reviewed, to ascertain the requirements for 2009-10.
- 10. It is acknowledged that the data flows detailed in Annex A is not an exhaustive list of those affected by the merging of NHS Trusts, thus further work will be undertaken with Policy, Health Statistics and information colleagues to ensure that all data flows have an identified action plan. Those still requiring guidance are detailed in Annex B, further advice on these will follow early in 2008-09.

Phase one: current corporate data and information flows, key issues and recommendations

Actions Required

- 11. Trusts are required to;
 - Ensure the data submitted centrally contains either their new or old Trust code, as detailed within Annex A.
- 12. Health Solutions Wales (HSW) are required to;
 - Maintain the ability to report by old Trust and new Trust as stipulated by Policy and Health Statistics colleagues and as reflected in Annex A.
- 13. Business Services Centre (BSC) are required to;
 - Ensure those submissions processed by the BSC on behalf of the Welsh Assembly Government are submitted as per the requirements outlined in Annex A.
