DATA SET CHANGE NOTICE

Introduction

Phase one roll-out of the Emergency Department Data Set commenced from 1st April 2009 as set out in DSCN (2009) 02 (W). Experience gained during this phase has resulted in the changes described below.

A further DSCN will be issued to revise the data item 'Accident and Emergency Diagnosis Type' as work is currently being undertaken to review the types of diagnosis required.

The validity of Local Health Board Emergency Department Data Set activity data will be monitored via a set of EDDS Data Validity Standards, which are due to be introduced effective from 1st April 2010 onwards.

Description of Change

The following changes are being applied to the Emergency Department Data Set:-

- Inclusion of value '11 Dead on Arrival' in the Data Item 'Outcome of Attendance'
- Inclusion of note relating to the use of 'Dead on Arrival' in 'Attendance Group'
- Removal of the data items 'Clinical Handover Date' and 'Clinical Handover Time'
- Removal of data item 'Consultant Code'
- Inclusion of values for 'Not Applicable' in the data items 'Sports Activity 'Road User' and 'Arrival Mode'

Data Dictionary Version

This DSCN will be reflected in version 2.22 of the NHS Wales Data Dictionary.

Actions Required

Actions for Health Solutions Wales: -

- 1. Create new generic data load script accounting for amendments and the removal of data items.
- 2. Manage NHS Wales Data Switching Service allowing LHBs to submit data extracts via Secure File Upload to the HSW file server in agreed timescales.
- 3. Maintain database, validate and load data onto the EDDS National Database.

Actions for Local Health Boards:-

- 1. Continue to submit the Emergency Department Data Set as per the submission requirements issued in DSCN (2009) 02 (W).
- 2. Include additional reporting values contained within this DSCN from 1st February 2010.
- 3. Remove the data items specified in this DSCN from submission extracts by 1st April 2010.
