DATA SET CHANGE NOTICE

A Data Set Change Notice (DSCN) is an information mandate for a new or revised information standard.

DATA SET CHANGE NOTICE

Introduction

<u>DSCN (2007) 01 (W)</u> mandated a change to the reporting of 'Outcome of Attendance' within the Outpatient data set, introducing new values designed to capture the effect on a Referral to Treatment Times (RTT) period of each outpatient attendance.

The changed codes do not enable the reporting of a valid code for specialties that are not subject to RTT measurement, such as Mental Health. Since the introduction of DSCN (2007) 01 (W), Local Health Boards (LHBs) and Trusts have regularly queried how to report activity not subject to RTT measurement, with most working up local workarounds whereby the RTT-specific codes were used.

This DSCN introduces a valid 'Outcome of Attendance' code for specialties not subject to RTT measurement.

Description of Change

The 'Outcome of Attendance' data item within the Outpatients data set has been updated to include a value of '9 – Speciality Not Subject to Referral to Treatment Times (RTT) Measurement'.

Data Dictionary Version

Where applicable, this DSCN reflects changes introduced by DSCN and/or DDCN since the release of version 3.3 of the NHS Wales Data Dictionary.

The changes introduced by such DSCNs will be published in version 3.4 of the NHS Wales Data Dictionary.

Actions Required

Actions for Local Health Boards / Trusts:

• Update local data collection processes within appropriate systems (e.g. PAS) to ensure the appropriate reporting of 'Outcome of Attendance' codes within the Outpatient data set.

Actions for the NHS Wales Informatics Service (NWIS):

- Update national data processing and validation services (e.g. NHS Wales Data Switching and Validation at Source services) to allow for the reporting of the revised values for 'Outcome of Attendance', within the outpatient data set.
- Ensure all tools associated with the monitoring and reporting of outpatient activity data validity (e.g. Outpatient Activity Data Validity Performance Monitoring Report) fully reflect the code change outlined within this DSCN.
