### DATA STANDARDS CHANGE NOTICE

### **Introduction**

The Sexual Health in Wales Surveillance Scheme (SWS) has been collecting anonymised, patient-level data from sexual health services in Wales since 2011, in order to support the monitoring of sexually transmitted infections (STIs), facilitate assessment of local service needs and evaluate interventions to prevent and control STIs. The data collected include STI diagnoses and STI related services, as well as patient demographic details and clinical and risk factor data.

With the integration of sexual health services in Wales, there is a need to expand the scope of SWS to include clinical activity in both hospital and community clinics in Wales and to extend the data collection to reflect the services provided by integrated clinics, which include contraception and other sexual health activity. There is also a need to incorporate new data items that reflect recent changes in the epidemiology of sexually transmitted infections, for example: the increasing use of social media to find sexual partners, and the use of recreational drugs in sexual activity. This development of SWS is referred to as SWS2.

This notice introduces a new standardised national data set for Wales. During a pilot phase, Public Health Wales will be working with sexual health services and current software suppliers to assist services in adopting this national dataset, including any new fields, and in the transfer of this expanded dataset to the Sexual Health in Wales Surveillance Scheme (SWS). Sexual health services are encouraged to adopt national activity codes where local equivalents are currently in use.

This national standard will be used to inform the specification of a future National Clinical Management and Surveillance System for Sexual Health in Wales. Technical information required for the development of this system such as field length, date format, etc., is not referenced in this document.

### Description of Change

To introduce a new standardised national dataset for sexual health in Wales as described in the Information Specification below.

Sexual health services are defined as those provided within NHS Wales, however it is envisaged that this Standard could be applied to Third Sector Providers in the future.

We will be working with NWIS and Public Health England to make this standard SNOMED CT compliant in future.

### Data Dictionary Version

Where applicable, this DSCN reflects changes introduced by DSCN and/or DDCN since the release of version 4.9 of the NHS Wales Data Dictionary.

The changes introduced by such DSCNs will be published in version 4.10 of the NHS Wales Data Dictionary.

### Actions Required

NHS Wales Sexual Health Services:

• Work with Public Health Wales to adopt the information requirements as described in this DSCN, and to adopt the national activity codes in particular.

Public Health Wales:

- Ensure that separate guidance referred to in this DSCN is available for health boards to access, and notify them of any changes to this guidance.
- Work with software solution providers and project colleagues to ensure adoption of the Standard in any future software development or procurement for the collection and transfer of such information.

#### <sup>1</sup> With regards to the values within this table:

Not assessed indicates that the Data Item has not been collected. This would be at the discretion of the clinician in line with existing clinical practice guidance.

Unknown indicates that the clinician has attempted to collect the information from the patient but was unable to record a response (this could be for a variety of reasons e.g. patient was asked but declined to provide a response.)

#### The only exceptions to the above are:

GP Practice Code where Unknown is as the definition in the NHS Wales Data Dictionary i.e. where it is not possible to determine a patients registered practice code, for instance the patient cannot communicate and is unidentifiable.

HIV Status where Unknown reflects patients who do not have HIV codes that indicate they are positive (HIV care, HIV positive, HIV diagnosis codes), and do not have any HIV testing codes.

Gender of Patient, Gender Identity Same at Birth and Ethnicity, which comply with NHS Digital Standards and use the term Not Stated to denote that patient was asked but declined to provide a response.
