### DATA STANDARDS CHANGE NOTICE

A Data Standards Change Notice (DSCN) is an information mandate for a new or revised information standard.

This DSCN was approved by the Welsh Information Standards Board (WISB) out of committee on 21<sup>st</sup> December 2018.

#### Summary:

This standard is the first phase in updating the Outpatient data set scope to reflect modern models for providing care and treatment. The change to the Outpatient data set is reflected in a similar change to the scope of the Outpatient Referral data set.

## **DATA STANDARDS CHANGE NOTICE**

### Introduction

The 2016/17 Welsh Costing Return (WCR4) 'Activity Reconciliation' return, prepared annually by health boards, highlighted discrepancies between outpatient activity levels recorded and reported formally to NHS Wales via NHS Wales Informatics Service (NWIS) and activity recorded locally in health boards.

Currently there is outpatient activity captured locally that does not meet the Outpatient data set scope definition and therefore not reported nationally to NWIS. In addition, there is inconsistency in terms of health board compliance with the existing scope definition of the data set, with some health boards including all nursing activity, not just independent nurse led activity, some submitting nurse activity under the code of the consultant, and others not submitting any.

The omission of significant activity from the data submitted means that published activity reports may materially understate the level and range of clinical services delivered by NHS Wales. Additionally, if activity remains unreported, or continues to be categorised incorrectly and inconsistently, the unit costs of healthcare services in Wales could be misrepresented.

This Standard represents the first stage of a phased approach, aimed to introduce new and updated data definitions associated with outpatient activity, in order to reflect modern models for providing care and treatment and present a more accurate account of the services being delivered.

## Description of Change

To increase the scope of the Outpatient data set (OP ds) and Outpatient Referral data set (OPR ds) to include nurse led activity, specifically to:

- Update the definition scope of the OP Ds to encompass activity as outlined in Appendix B.
- Update the definition scope of the OPR Ds to encompass activity as outlined in Appendix B.
- Update the Data Item Consultant Code, for OP ds only, to support the national submission of the Registration Number for any nurse (including midwives) meeting the definition of Clinic Appointment (Nurse Led). Where the Registration Number for the nurse or midwife is not registered with the Welsh Reference Data Service (WRDS), that the following codes should be used:

M9999998 - Midwife

N9999998 - Nurse

## Data Dictionary Version

Where applicable, this DSCN reflects changes introduced by DSCN and/or DDCN since the release of version 4.9 of the NHS Wales Data Dictionary.

The changes introduced by such DSCNs will be published in version 4.10 of the NHS Wales Data Dictionary.

## Actions Required

Actions for Local Health Boards / Trusts:

- Apply the additional clarity provided by the scope definitions for the OP Ds and OPR Ds
- Report Consultant Codes for OP Ds according to the guidance in Appendix B
- Implement the revised scope and additional codes in 2018-19 annual resubmissions i.e. in data, with appointment dates from 1<sup>st</sup> April 2018 to be submitted in June 2019.
- Work to add nurse and midwife registration numbers to the Welsh Reference Data Service (WRDS) and incorporate these identifiers into OP ds records

Actions for NHS Wales Informatics Service:

- Update VASS check 51213: Invalid Consultant Code to reflect the changes to Consultant Code

Actions for NHS Finance Delivery Unit:

- Work to the revised scope and additional codes submitted by health boards in their 2018-2019 annual costing submissions

### **Scope Outpatient Data Set**

The Outpatient (OP) Data Set captures data for all consultant or ~~non-consultant/nurse~~ led clinic activity **where that meets the criteria outlined in [Terms Clinic Appointment – Consultant Led \(Outpatients\)](#) or [Terms Clinic Appointment – Nurse Led \(Outpatients\)](#).**

Any activity which is not consultant or ~~non-consultant/nurse~~ should be excluded. Also excluded are:

Community ~~non-consultant/nurse~~ led activity

Both attendances and non-attendances are within scope, including DNAs, CNAs and hospital cancellations (see <http://howis.wales.nhs.uk/sitesplus/documents/407/Final%20Master-%20RTT%20-%20rules%20document-%20Just%20RTT-April%202017.pdf>)

All NHS activity regardless of the care provider is included. Private patients seen at an NHS organisation are also included.

NHS Digital provide data on Welsh resident or registered patients treated in English NHS organisations.

### **Scope Outpatient Referral Data Set**

The Outpatient Referral (OPR) Data Set captures all referrals received by NHS Wales' provider organisations for a first outpatient appointment for all consultant or ~~non-consultant/nurse~~ led clinic activity, **where that meets the criteria outlined in [Terms Clinic Appointment – Consultant Led \(Outpatients\)](#) or [Terms Clinic Appointment – Nurse Led \(Outpatients\)](#)** regardless of the patient's area of residence.

The data set includes referrals from any source and is not limited to only those referrals made by a GP.

### **Terms Clinic Appointment – Consultant Led (Outpatients)**

This is a scheduled outpatient appointment for a patient to see a consultant (or a member of their firm) for the purpose of a consultation, or an outpatient procedure.

A consultant is a person contracted by a Health Care Provider who has been appointed by a consultant's appointment committee. He or she must be a member of a Royal College or Faculty. This also includes clinics run by General Practitioners acting as a Consultant.

This excludes:

Nurses, independent nurses or midwives who may be part of the consultant's firm but lead their own clinics (see [Clinic Appointment – Non-Consultant/Nurse Led \(Outpatient\)](#))

### **Terms Clinic Appointment – Non-Consultant/Nurse Led (Outpatients)**

This is a scheduled outpatient appointment for a patient to see a nurse for the purposes of an assessment, treatment, advice or counselling. These appointments take place in clinics where nurses/midwives have their own list of patients who are not expected to see, or be in contact with, a doctor (even though they may refer patients to the doctor be seen or be in contact during the same attendance or contact).

A nurse/midwife is a person whose name is registered in the Nursing and Midwifery Council Register maintained by Nursing and Midwifery Council. Historically, Local Health Boards /Trusts have used different titles to denote nurses carrying out nurse-led activity e.g. Independent Nurse, Specialist Nurse, Clinic Nurse Specialist, Nurse Practitioner and Nurse Consultant.

For the purpose of the scope of the Outpatient (OP) Data Set and Outpatient Referral (OPR) Data Set, all nurses and midwives are included, providing they meet the aforementioned criteria. Such activity should be identified as ~~non-consultant~~/nurse led. See [Consultant Code](#)
